## FINAL TAX RETURNS

Certain people need to calculate their income earned over the one-year period **from 1 January to 31 December of 2025**, calculate the amount of tax to be levied on this sum and file their income tax returns. This is not necessary for the majority of salary income earners, but people who fall into one of the categories below need to file a final return:

- salary is paid at two or more places
- a year-end adjustment is not performed by the employer
- the person has business income
- yearly income is more than 20 million yen
- the person has more than ¥200,000 of income from other than salary
- the person can take certain deductions (e.g. for medical expenses, charitable contributions, housing loan etc.)



It's convenient to file your final tax return from a PC or smartphone using e-Tax!



**When to file: Monday, February 16 to Monday, March 16, 2026**

**There were some revisions to the tax regulations in 2025.**

**The basic deduction and the employment income deduction have both been adjusted, and a "Special Exemption for Specified Relatives" has been added.**

**Basically, these changes went into effect from the 1st of December, and apply for that month and afterward. For more information see the homepage of the National Tax Agency.**
